Opening

Bellamy Woods Civic League Vice President Kyle Bullard brought the meeting to order at 7PM EDT in the library of Providence Road Elementary school. Eleven persons were present, each of which indicated current membership in the league. There were no guest speakers this evening. The meeting agenda membership forms, and 2013 calendar were available for pickup at the door. Copies of the previous meeting minutes were available on each table.

Elections

President Walter Camp presented the nominations for the 2014 calendar year. Renewing their service to the community are Frank Gewet, Cathe Waters, Dr. John Sokolowski, John Glenn, Walter Camp, and Greg Turpin. The membership in attendance unanimously agreed to the nominations. Vice President Kyle Bullard is not renewing for the next term. A resident asked about the Violet Bank Bike path, specifically, if we had obtained the interest of the Selwood residents. Mr. Camp stated that he had obtained the consent of residents within our league and that there remains a need to reach out to the homes between Selwood and Stratford Chase as the city wants to hear from the homeowners in order to ensure residents are amenable to construction along this corridor. John Glenn volunteered to canvass these residents in order to solicit their interest or aversion to this project.

Mr. Camp called for any additional business. Hearing none, he adjourned the meeting at 7:15PM EDT.
